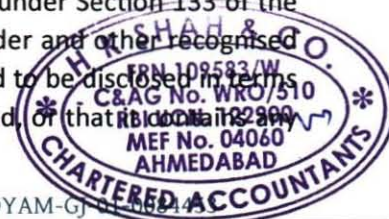
Qualified Conclusion

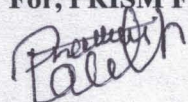
